

## AA Smartfuel / Qantas Frequent Flyer Competition Terms & Conditions

1. Have your Qantas Frequent Flyer account linked to your AA Smartfuel account by the promotion end date to go in the draw to win the Prize. ("**Promotion**").
2. All successfully linked accounts qualify for one entry to the Promotion.
3. By linking your Qantas Frequent Flyer account with your AA Smartfuel account, you indicate to the Promoter that you wish to enter this Promotion.
4. The Promotion closes on 31 January 2021 ("**Promotion Period**"). By accepting the Prize, you agree to the terms of the competition. Records of the Promoter are final and conclusive as to time the accounts were linked.
5. If you become an AA Smartfuel cardholder during the Promotional Period, you must register your card with AA Smartfuel by 31 January 2021, otherwise you do not qualify to enter this Promotion, and your entry will be deemed to be null and void.

### PRIZE:

6. All entries go in the draw to win one Prize of six (6) seats on a return Qantas economy class flight departing from Auckland, New Zealand to Coolangatta, Australia (1 prize winner and 5 travel companions must travel together on the same flights in both directions), 3 nights' accommodation in three twin share rooms at Ultiqa Air on Broadbeach, Qantas lounge access on departure from Auckland and is valued at \$8,000. #### Prize Details:

##### Flights Prize

The maximum total flights Prize value is NZD4000 based on the recommended retail value at the time of printing.

Prize travel is subject to S Class (or below) availability at the time of booking. The Prize does not include travel insurance, passports, visas and meals are not included in the price of the ticket, ground transportation or any other costs of a personal nature not specifically stated. Compliance with any health or other government requirements is the responsibility of the prize-winner and their companions. Prize travel is subject to Qantas' General Conditions of Carriage.

#### **WINNERS:**

18. The Promoter is not responsible if the Winner cannot be contacted due to incorrect details registered on the AA Smartfuel or AA Membership card.
19.
