Our Rural Roads Driver Assessment is specifically designed for drivers in rural areas. The report will identify those aspects of your driver's behaviour and actions that might need improvement to reduce crash risk. In this rural roads assessment we allow extra time to ensure we can cover a variety of rural roads and driving scenarios.

A Rural Roads Driving Driver Assessment will potentially identify further training needs and form part of your overall driving policy to meet Health and Safety objectives and compliance needs.

What's included:

The Rural Roads Driver assessment is a 75 minute one on one session with an AA Driving Instructor. During the session we will conduct a full assessment of driving behaviour, attitude and capability from a health and safety perspective including the following:

- Challenging road conditions.
- Safety checks
- Manoeuvres
- Road positioning
- Traffic signals
- Fuel efficient driving
- Observations
- Speed selection

The additional 15 minutes allows extra time to focus on driving on unsealed or gravel roads and engaging 4WD mode if necessary.

Please note: this assessment takes place on-road. For off-road 4WD training please see Factsheet 9 4WD Off-Road Safety course.

The assessment process encourages interaction and discussion, and allows the AA Driving Instructor to pinpoint any areas for improvement and identify the individual's training needs. The AA Driving Instructor will also give practical advice to help the driver improve.

Based on their observations the AA Driving Instructor will produce a report that details the drivers level of competency across various driving tasks and will

Requirements:

This session is suitable for all driving staff. We require the following information at the time of booking:

- Name of all participants
- Contact number for all participants
- Make and Model of vehicle for all participants
- The business address to meet the instructor for the session or this can be an AA Centre
- Email address of manager who should receive the final report

The session will take place in the participants own vehicle or company vehicle. You will need to ensure they are aware of this and that they have a vehicle available to them on the day of the assessment.

On the day of the session each participant is required to:

- Have their full or restricted driver licence to hand
- Provide a vehicle for the session with up-to-date WOF and Registration

Please ensure all participants arrive to the session and are ready to begin the drive at the allotted time. Delays may mean they cannot drive for the full 60 minutes and our instructors may not be able to fully assess their driving.
